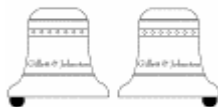

## To get to Culver by car

### From The Northwest (Chicago)

Take Interstate-80, I-90 or I-94 East to Indiana 49 (near Chesterton) and turn South (toward Valparaiso)  
Take US 30 East (toward Plymouth – this junction is at Valparaiso).

At US 35, turn South (toward Knox). South of the main downtown area, turn left (East) on Culver Road (also marked as Indiana 8). If you pass the hospital you have gone too far.

When Indiana 8 ends (flashing light), turn right (South) onto Indiana 17. This junctions with Indiana 10 on the North side of Culver. Take Indiana 10 East (left) to go directly to the Chapel. To go to registration, motels, and meeting areas, proceed straight through the 4-way stop at Indiana 10, then left at the next 4-way stop (Academy Road). As you begin coming back uphill, turn onto drive on the right (just before the auditorium building) or park on Academy Road. Registration will take place in the foyer of Eppley Auditorium (enter by East doors, toward the “selectively polished” fountain).

### From the toll road to the Northeast (Michigan, Ohio, Pennsylvania, etc.)

Take Interstate 80/90 West to junction with US 31. Take US 31 South (a bypass highway that wraps around the West side of South Bend, going right by the airport), past Plymouth (US 30), to Indiana 10 (at Argos). Turn right (West) onto Indiana 10. Beware of the four right-angle turns, staying on the main road. The Academy Chapel will come into plain view on your left after 10 miles. To get to the registration area, turn left (South) onto Academy Road, which is the first opportunity for a left turn past the Chapel (West of it). Academy Road does a right angle turn, and soon thereafter, the auditorium comes into view.

### From the South

Come up on US 31 North (which connects to I-465 in Indianapolis). Through Kokomo (annoying traffic lights), past the former Grissom Air Force Base, past Peru and Rochester. Eventually, you come to Indiana 10 (by Argos). Turn left (West) on Indiana 10, and the Academy Chapel will come into plain view on your left after 10 miles. To get to the registration area, turn left (South) onto Academy Road, which is the first opportunity for a left turn past the Chapel (West of it). Academy Road does a right angle turn, and soon thereafter, the auditorium comes into view. **NOTE: There is no easy way from the Southwest. I recommend going by way of Indianapolis (I-465 to US 31).**

### To go to Plymouth Hotels

From the West: Continue on US 30 until you reach the shopping area with Super 8 Motel on the South side (Oak Road). The other cluster of hotels is the next actual exit, connecting to Indiana 17. Days Inn is almost straight ahead. The others are just north of the US 30 underpass.)

From the East: Continue past US 31 exit. Take next exit (connecting to Indiana 17) for Days Inn (just South of US 30), or (just North) Villager Inn, Holiday Inn Express, and Ramada. For Super 8, continue West until a shopping center appears on your right. At the traffic light (Oak Road), turn left (South), and watch for drive to Super 8 quickly on your left.

### From Plymouth Hotels to Culver

From Villager Inn, Days Inn, Ramada, and Holiday Inn Express, return to US 30 West, turn left at the next traffic light (Oak Road). (Super 8 guests skip this first step and turn directly onto Oak Road.) Proceed South, over railroad tracks, and South of town, this road becomes Indiana 17. After about 14 miles, this junctions with Indiana 10 on the North side of Culver. Take Indiana 10 East (left) to go directly to the Chapel. To go to registration, motels, and meeting areas, proceed straight through the 4-way stop at Indiana 10, then left at the next 4-way stop (Academy Road). As you begin coming back uphill, turn onto drive on the right (just before the auditorium building) or park on Academy Road. Registration will take place in the foyer of Eppley Auditorium (enter by East doors, toward the “selectively polished” fountain).
